

# THE CONTRACT

A limited-time wedding photography offer for 2026 & 2027 weddings, available to book between April and May 31<sup>st</sup> (at midnight) 2026.

## What's included:

- 1 Photographer
- Up to 8 Hours Coverage
- 300 Edited Images
- 10 Sneak Peeks within 1 week
- 1 Consultation
- Online Gallery with Access & Sharing Options
- Add-ons available upon request

## Terms & Conditions for Wedding Photography Package:

### 1. Booking and Payment

1.1. A non-refundable 50% deposit (including additional costs as per section 3) is required to secure your booking. The deposit is £475 and will be deducted from the total package price of £950.

1.2. The remaining balance of £475 is required upon delivery of the final gallery. Access to the gallery and its contents will be granted once full payment has been received.

1.3. Payment details can be found on the invoice issued to the client by the photographer.

1.4. The £475 deposit is non-refundable under any circumstances, including cancellation by the client.

### 2. Package Details

2.1. The offer includes 8 hours of photography coverage on the wedding day, taken consecutively from start to finish (e.g., 12:00–20:00, including a break). The coverage cannot be split across different parts of the day.

2.2. A minimum of 300 high-resolution images will be provided via an online gallery. The photographer will choose and professionally edit the best images from the day.

2.3. This package does not include any additional services such as albums, prints, or extra hours of coverage. These may be purchased separately.

2.4. The photographer reserves the right to modify the number of images delivered based on the circumstances of the day (e.g., delays, uncooperative lighting, etc.).

2.5. The photographer is entitled to a 30-minute break during the coverage, typically taken during the meal when no photos are required.

### **3. Additional Costs**

3.1. Any additional hours of photography coverage will be charged at £150 per hour.

3.2. Travel expenses outside a 20-mile radius of SE18 will be charged at £0.65 per mile each way.

3.3. If an overnight stay is required for the photographer due to the wedding/event location or coverage needs, an additional charge of £150 will apply for the photographer's accommodation and time away. This charge will be added to the deposit to ensure accommodation is secured in advance.

3.4. Any other additional requests outside the agreed package may incur extra charges and shall be discussed via email/messages before the deposit is made.

3.5. Any add-on hours decided upon on the day of the shoot will be added to the final invoice. Likewise, any add-on hours agreed between booking and the shoot date will also be added to the final invoice.

### **4. Cancellations and Rescheduling**

4.1. Cancellations: If the client cancels the wedding at any time, the deposit will be forfeited. Additionally, any pre-booked accommodation or travel arrangements (e.g., hotels, flights, etc.) are non-refundable. The client will be responsible for covering these costs, which must be paid at the time of the initial booking.

4.2. Rescheduling: If the client wishes to reschedule the wedding, the deposit may or may not be transferable. The deposit can only be transferred to a new date, subject to the photographer's availability. If the photographer is unavailable for the new date, the deposit will not be refunded.

4.3. Accommodation and Travel Costs: Any accommodation or travel costs already booked for the original wedding date will remain non-refundable, even in the case of rescheduling. The client will be responsible for covering these costs, as well as any new accommodation or travel charges if the wedding is rescheduled to a different date.

4.4. In the highly unlikely event the photographer cannot attend the wedding due to illness, death, fire, or other unforeseen circumstances, the following options are available:

**Substitute Photographer:** A professional substitute may be arranged to cover the event and may, at the photographer's discretion, also complete the editing of the gallery.

**Adjustment or Termination:** If the client does not accept the substitute, or if a suitable replacement cannot be found, the client may terminate this agreement and all payments made (including the deposit) will be fully refunded.

## **5. Client Obligations**

5.1. The client is responsible for ensuring the photographer has access to all necessary locations and venues on the wedding day.

5.2. The client agrees to inform the photographer of any special requests, limitations, or restrictions at the venues before the wedding day.

5.3. The client agrees to provide the photographer with a timeline of the wedding day at least two weeks before the event.

5.4. The photographer is not responsible for missed shots due to factors outside their control, including but not limited to inclement weather, poor lighting, or venue restrictions.

5.5. The client is responsible for informing the photographer in advance if a DJ or lighting setup involving lasers will be used. The photographer is not liable for any impact such lighting may have on image quality or equipment safety, and may request that lasers are reduced or temporarily disabled during key moments where necessary.

5.6. The client is responsible for ensuring that the officiant or person conducting the ceremony is informed in advance of the photographer's presence, and that permission is granted for the photographer to move discreetly during the ceremony in order to capture key moments.

## **6. Usage Rights and Copyright**

6.1. The photographer retains the copyright of all images. The client is granted a license to use the images for personal use only.

6.2. The client may share images on social media or print copies for personal use but may not sell, license, or modify the images without the photographer's permission.

6.3. The photographer may use the images for promotional purposes, including but not limited to social media, portfolios, and marketing materials.

## **7. Limitations of Liability**

7.1. The photographer's liability for any loss, injury, or damage arising from the provision of services is limited to the amount paid by the client for the wedding photography package.

7.2. The photographer is not liable for any failure to deliver services or images due to circumstances beyond their control, including but not limited to natural disasters, technical failures, or acts of God.

## **8. Agreement**

8.1. By booking the photographer's services, the client agrees to these Terms and Conditions.

8.2. These Terms and Conditions are subject to change at any time, but the client will be notified of any amendments.

## **Applicable Law**

This agreement shall be governed in accordance with the laws of England and Wales.
